20. CODE OF CONDUCT

Members were reminded of their responsibility under the Code of Conduct in respect of making declarations of interest and that any declarations should be made now.

21. MAYOR'S REPORT

"I would like to extend my thanks to everyone involved at the Milton Rooms who hosted Radio 4 Any Questions last Friday, 16th June 2023. The staff and volunteers did an amazing job, and it was very well attended with councillors, residents of Malton and the surrounding area. The panel were all very interesting, and a good range of questions. Of the 5 questions, the 2nd was on food poverty and children going hungry, including here in Ryedale, and all the panel agreed on the urgent need to address this issue. The 3rd question was one from me as Malton resident and Mayor, asking the panel what they thought about making 20mph the national default urban speed limit, and all 4 expressed support for making 20mph the default limit in urban areas, backing this council's position in Malton, and that the Westminster Government and/or North Yorkshire Council should just get on and do it."

The Mayor also attended the Ryedale Branch meeting of the Yorkshire Local Council's Association.

23. NORTH YORKSHIRE COUNCIL MEMBER REPORT

Cllr Burr reported on her role at North Yorkshire Council. "Since our last meeting, it has been super busy some days, we as Councillors have ten hour days with two meetings at different places of North Yorkshire Council! I can report the Scrutiny of Health Committee is a really good cross party committee trying to ensure our healthcare is strengthened.

The Area Committee dealt with many local concerns, I am particularly concerned about daytime meetings only, and I am hoping to get this changed to allow better public participation. I am pleased to report after a lot of lobbying from not only myself but Gail as well, we have had notification from North

Yorkshire Council that Highfield Road and Pasture Lane are to be resurfaced this year. Also, we are progressing now with the Wentworth Street project.

The Police Crime and Fire Panel met today to discuss the damming report, showing four areas of inadequacy. The Commissioner reported they had made improvements and the Inspectors will be back in October. This is a cross party committee. I raised a lot of questions, the main being, when will we get more Police on the beat.

Finally, £1,000 funding for the Malton & Norton Operatic Society has been approved from my locality budget."

28. HIGHFIELD ROAD & SURROUNDING ROADS

Councillor Burr confirmed that Highfield Road and Pasture Lane, Malton will be resurfaced this year. It was **agreed** that the Clerk to send a letter to Cllr Keane Duncan requesting that East Mount, Milton Avenue and Showfield Lane be resurfaced to a high standard. Also, request that North Yorkshire Highways consider yellow lining areas of of the road on Showfield Lane.

29. NORTH YORKSHIRE EXECUTIVE COMMITTEE MEETING UPDATE

(i) 20s Plenty

RESOLVED

That Members support the policy outlined in the speed review – default 20mph limits for North Yorkshire villages and towns, with the exceptions to 30mph where it is safe to do so, phased over 3-4 years costing a one off £5-£10 per head. Proposed by Cllr Conlan, seconded by Cllr Burr. Cllrs Oxley, Ennis and Hawes voted against, Cllr Aldrich abstained. Cllr Conlan used his casting vote in support, therefore, the Motion was carried.

(ii) Update Members on the Ryedale CIL

Cllr Burr updated Members with regard to the decision by the North Yorkshire Executive to refused the CIL funding applications previously approved by Ryedale District Council.

It was **agreed** to send a letter to North Yorkshire Council portfolio holder and head of service requesting an explanation with regard to the outcome of the Ryedale CIL funds. Letter to be circulated to Members prior to distribution.

30. <u>REPRESENTATIVES</u>

Review of the Ryedale Plan

Members **agreed** that Cllr Andrews and the Mayor speak on behalf of the Town Council at the meeting of the North Yorkshire Executive on 4th July with regard to the review of the Ryedale Plan. The Clerk to request a copy of the Officer's report on the Ryedale Plan Review as soon as it becomes available to Members of North Yorkshire Council.

Cllr Aldrich formally thanked Cllr Boler for organising the call to action at Lady Spring Wood involving a number of volunteers and North Yorkshire Fire & Rescue Red Watch. All volunteers worked extremely hard to remove the hymalyian balsam. It was **agreed** that the Clerk send a letter of thanks to Peter Winter, Ryedale Environmental Group and NYF&RS Red Watch for their hard work.

31. MEMBERS QUESTIONS

Cllr Thackray requested that the Clerk contact Yorkshire Water to request a tour of the sewerage treat works at York Road Industrial Estate, Malton and raise the issue of businesses affected by the frequent awful odour in the town.

Following concerns raised by Cllr Thackray with regard to the lack of signage on York Road Business Park, it was **agreed** that the Clerk send a letter to the land owner, requesting that the signage be improved on the site.

The Clerk updated Members with regard to the request from Cllr Thackray for a hard standing on York Road to enable the speed camera van to be deployed and consider the installation of speed camera warning signs.

NY Highways reported that the only instance where they would consider the installation of speed camera warning signs would be if a permanent fixed camera was present. They do not erect them at mobile locations as this would result in a proliferation of signs across the County when nationally we are being encouraged to de-clutter the highway of signage. Additionally these signs would have little benefit with drivers soon becoming aware of the infrequent presence of the speed camera.

NY Highways would not support a hardstanding for vehicles at that location as there are a number of underground utility services at that location which would be problematic. The location of a parked vehicle would also be detrimental to highway safety as it would obscure visibility for a vehicle trying to exit the side road or indeed pedestrians using the adjacent drop kerb crossing. Any hard surface area would also increase the maintenance burden on the public purse.

Cllr Thackray to revisit the site and communicate any alternative options to the Clerk.
