#### 125. CODE OF CONDUCT

- 2. Are Yorkshire Yorkshire collating pollution reports, to provide evidence to the Environment Agency?
- 3. Is the overflow foul water or surface water?

# 131. <u>MINUTES OF THE RYEDALE DISTRICT COUNCIL MEETING HELD ON 7<sup>TH</sup> OCTOBER 2021</u>

Cllr Thackray presented a report (previously circulated).

In the Minutes of the meeting of Ryedale District Council held on 7<sup>th</sup> October 2021 it was resolved:-

"This Council wishes to reaffirm the 22-5 decision taken on 27th June 2019 in relation to support for duelling the A64 between York and Scarborough, as well as other improvements in between, including the urgent completion of new slip roads on/off the A64 at the B1257 Broughton Road and construction of a new roundabout at Musley Bank in response to the 2021 World Health Organisation air quality guidelines. The Council calls on the Chairman of Policy & Resources to work with our Officers, other local authorities, National Highways, business leaders and MPs to ensure that this work takes place as quickly as possible in line with legally binding climate change commitments at the time of the project's commencement."

#### RESOLVED

That the Town Council write to Cllr Duncan, all North Yorkshire Council Executive Members, Kevin Hollinrake MP and the Transport Minister to request that they all pay special attention to the Ryedale District Council resolution below and do not allow the idea of duelling of the A64 and its potential benefit to the North Yorkshire economy to distract the council, or come before the health of the people of Malton and Norton, which is being harmed due to the failure of North Yorkshire Council to provide the infrastructure the towns require. Proposed by Cllr Thackray, seconded by Cllr Andrews, all other Members approved.
